USAGE CONDITIONS AND PAYMENT OF FEES

Only GCU Benefit Members (Certificate Holders) are entitled to use Seven Oaks Country Club Inc.
These privileges are not transferable to family members or guests.

Dining:

- ✧ Unlimited dining in the Clubhouse. Reservation restrictions may apply to special events—reservations are preferred.
- ✧ Benefit Members must accompany their guests. Spouses & children who are not benefit members are classified as guests.

Golf:

- ✧ Three (3) complimentary green fees. You are required to pay cart fee.
- ✧ Three (3) additional uses paying the current green fees & cart fee.
- ✧ Tee times available 3 days in advance.
- ✧ Weekend or holiday tee times available starting at noon.

Golf Fees:

- ✧ Cart fee (18 holes) - \$35 per person (inclusive)
- ✧ Cart fee (9 holes) - \$23 per person (inclusive)
- ✧ Green fees (18 holes) - \$80 weekdays - \$95 weekends
- ✧ Green fees (9 holes) - \$40 weekdays - \$45 weekends

Swimming:

- ✧ Restricted to 3 times per year.
- ✧ Children must apply for a benefit membership or will be classified as a guest.

Swimming Fees:

- ✧ GCU Adults - \$15 per person (Mon.-Thur.) - \$20 per person (Fri.-Sun. & Holidays)
- ✧ Non-GCU Guest Adults - \$20 per person (Mon.-Thur.) - \$25 per person (Fri.-Sun. & Holidays)
- ✧ GCU Children ages 3-12 - \$10 per person (Mon.-Thur.) - \$15 per person (Fri.-Sun. & Holidays)
- ✧ Non-GCU Children ages 3-12 - \$15 per person (Mon.-Thur.) - \$20 per person (Fri.-Sun. & Holidays)
- ✧ Children age 2 & under - NO Charge

Tennis & Pickleball:

- ✧ Restricted to 3 times per year.
- ✧ Children must apply for a benefit membership or will be classified as a guest.

Tennis & Pickleball Fees:

- ✧ All ages (including Guests) - \$20 per person
- ✧ Children age 2 & under - NO Charge

Membership card must be presented to Club personnel for every usage.

**All purchases by GCU Limited Benefit members at Seven Oaks CC
must be paid by cash or credit card at time of purchase.**

before each visit for recreational and dining availability.***

SEVEN OAKS CLUBHOUSE DRESS CODE

Jeans: Dress jeans only will be permitted for adults and children in the Grille Room. These must be dress jeans - no holes, strings or cut-offs. This applies to the Grille Room only.

Shirts: Shirts with acceptable insignia will be accepted in the Grille Room. These must be in good taste with nothing offensive or vulgar. Tank tops are not permitted. For adult males, shirts with collars and sleeves are preferred and are required to be tucked in while in the Clubhouse.

Hats: **NO hats** permitted at anytime, please remove hats when entering the Clubhouse.

Oak Room and Ballrooms: (Sunday Brunch) Business casual attire is acceptable.

No denim, tee shirts, shorts, tennis shoes, flip flops or hats are permitted.

Attire NOT PERMITTED on Golf Course

NO Short shorts (must be walking shorts or Bermuda style).

NO Football pants, coaching or cut-away shorts, or college jerseys.

NO Jeans of any type.

NO Tank tops, fishnet tops, college jerseys or tops without collars.

NO Novelty tee shirts (with lettering).

The Golf Shop is obligated to enforce this dress code.

RELEASE OF LIABILITY FOR GOLF CART OPERATION

1. I agree that I will comply with any and all rules, regulations or instructions that may be provided to me by Seven Oaks Country Club, Inc. regarding use or operation of a golf cart.
2. I agree that I will assume full responsibility for my use, my guest use, or any member of my family's use or operation of a golf cart at the Seven Oaks Country Club, Inc. Recreational Facilities, and to reimburse Seven Oaks Country Club, Inc. for any damage to the golf cart and any and all property.

I hereby accept any and all risk of injury to myself, my guests and my family sustained while using the Seven Oaks Country Club, Inc. Recreational Facilities or involved in any event or activity incident to Limited Recreational Benefits in the GCU. In accepting the risk of injury, I understand that I shall indemnify and hold GCU and Seven Oaks Country Club, Inc. and their directors, officers, partners, shareholders, employees and affiliates harmless from any and all loss, cost, claims, injury, damage or liability sustained or incurred by me, my guests and my family resulting from or arising out of any conduct or event connected with Limited Recreational Member Benefits in the GCU and use of any of the Seven Oaks Country Club, Inc. Recreational Facilities.
